

GTDF Downtown Titusville Façade Improvement Project Application

The Greater Titusville Development Foundation (GTDF) created a Façade Improvement Project for downtown Titusville because the attractiveness of property and commercial buildings is important to the revitalization of any downtown. A downtown's image and the character of its buildings, created through the arrangement of form and type of detail, are products of the time it was built. New construction, additions and building façade rehabilitation should complement, not detract from, these original features. This grant project was developed to stimulate private investment in properties, foster an attractive environment and preserve the attractive character of downtown Titusville.

This project is made possible through private donations and funding from the Commonwealth of Pennsylvania, Keystone Communities Program.

The project will be administered by the GTDF Staff.

Quick Facts:

- The GTDF Downtown Titusville Façade Project grant limit is \$5,000 per façade.
- The grant must be matched dollar-for-dollar by the individual owner of the property or their leaseholders. (Leaseholder must show owner's approval)
- You must talk with GTDF staff about your project prior to submitting an application
- Applications will be reviewed by the GTDF Board of Directors. Applicants will be notified in writing whether they have been awarded a Façade Improvement Project grant.
- This is a reimbursement grant. Payment to the grantee of a qualified project is made in the form of a reimbursement. Copies of invoices marked paid by the Contractor as well as copies of cancelled checks are required to receive reimbursement. Reimbursement may take up to 14 days.
- Work started before the award of a Façade Improvement Project grant is not eligible for reimbursement.
- Contractor should not start work until they have received 50% down of the total project cost.

- Replacement of missing historic features
- Repointing , Painting and Exterior Decoration
- Repair and in-kind replacement of Windows, Doors Entrances and Stoops
- Façade roof repair
- Awnings, canopies, other window treatments
- Exterior Light
- Signage
- Removal of inappropriate materials
- Sidewalks
- Landscaping
- Architectural services

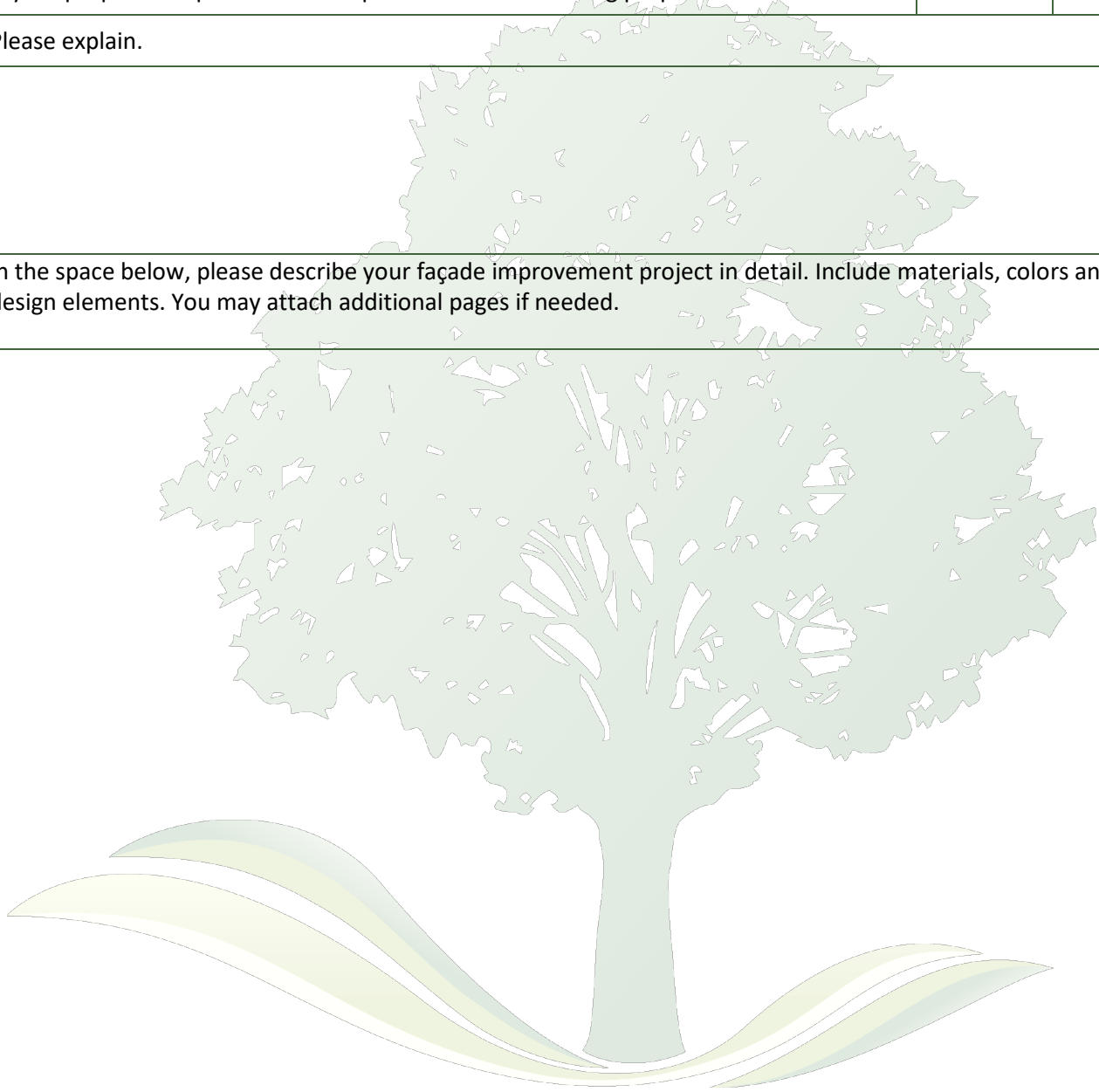
